### **You can support Council for Relationships with a Planned Gift by:**

- ❖ Designating a specific dollar amount or percentage of your estate to be given through your will;
- ❖ Identifying Council for Relationships as the beneficiary of your insurance policy, which does not require you to change your will or other aspects of your estate plan;
- ❖ Designating Council for Relationships as the beneficiary of all or part of your IRA (using a beneficiary designation form provided by your custodian). Of note, the full value of the gift is transferred tax-free at your death and your estate receives an estate tax charitable deduction; or,
- ❖ Donating readily marketable securities, including stocks, bonds, short-term commercial paper, and certificates of deposit.

### **Want to make a charitable bequest today?**

A charitable bequest is one of the easiest ways you can leave a lasting impact on Council for Relationships. Leaving a gift to Council can be accomplished by making a simple amendment to your will or trust.

If you are considering making a gift to Council through your will or trust or by beneficiary designation, you may wish to share the following language with your advisor:
